Dear Client,
please find here below a useful summary of the decree that governs the thoroughfare prohibitions in force in Italy in the year 2023 for trucks heavier than 7,5 tons. Yours faithfully.

PLOSE sistem service S.p.A.

... For trucks arriving from abroad and from Sardinia,, the above mentioned prohibitions begin four hours later. ... For trucks going abroad, the end of the above mentioned prohibitions is set two hours earlier. For the vehicles travelling to Sardinia.... the end of the prohibition is anticipated by four hours. ... This anticipation is extended to four hours for vehicles going to nationally relevant interports (...) and to the intermodal terminals of Busto Arsizio, Milan "smistamento" etc., and transporting goods with final destination in foreign countries.For trucks coming from or going to Sicily the above mentioned prohibitions start two hours later and end two hours earlier.... (..) The above-mentioned vehicles must show valid documentation ... attesting the destination of the goods.

All entries are given without prejudice.

... The prohibitions indicated does not apply either to vehicles (even if circulating empty) used for the transport of: ... milk, except for that of long preservation or liquid food, provided that in this latest case they carry or they are to pick up milk. These vehicles must be marked with signs indicating ... "d". ... Perishable goods in ATP system. ... Perishable goods ... such as fresh fruits and vegetables, ... cut flowers, live animals destined for slaughter or coming from abroad and live seedlings These vehicles must be marked with signs indicating "d".

... The prohibitions indicated moreover does not apply to vehicles, subject to adequate prefect authorization, carrying products that, due to their intrinsic nature or to climatic and seasonal reasons, are subject to rapid deterioration and therefore require prompt transfer from the production site to the deposits or sale locations. These vehicles must be marked with signs indicating "a".
